Purpose: To strongly support and motivate female students to pursue and develop skills in the field of Science.

The scholarship is \$2,500 for one year and will be used toward science education, events to promote student success and school tuition. To qualify, the student must meet several requirements and make a commitment to participate in science activities that will promote her success.

Scholarship Criteria

- Female student registered to enter 7th or 8th grade at OLGC school.
- Evidence of dedication to academics by a solid academic record.
 - Evidence that reflects outstanding character.
 - 75% or greater National Percentile in the subject of Science.
- Cumulative Science Grade of at least 90% during the most recent progress report period/school year.

Application Instructions

- Complete the application form.
- Must provide at least one (1) teacher recommendation highlighting the student's performance and enthusiasm in Science class.
- A minimum 2 paragraph essay and a maximum of 1 page essay in Arial or Times New Roman 12 font written by the applicant on the topic Science.
- No more than 5 unexcused absences and tardy from school in the most recent school year.
